**1. Correspondence received regarding Dundalk Parks (see below minutes for link to PDF correspondence)**

The Board received correspondence regarding issues going on at parking in Dundalk regarding bullying and violence by children towards other children. Staff Sergeant Ward confirmed that he just received the correspondence last night so did not have a chance to investigate the call history surrounding the parks but will get further information. Member Woodbury noted that the correspondence referred to children in the new development areas in Dundalk but that he wanted to communicate that this is an on-going problem and not all the issues are caused by children in the new development areas of Dundalk.

**2. Speeding on IDA Street South, Dundalk**

The Board held a discussion about speeding on IDA Street South in Dundalk. Staff have received complaints of the excessive speed in this area. Staff Sergeant Ward explained that cruisers have noted most motorists obeying the speed limit in this area while sitting and observing in unmarked police cars. He confirmed that OPP conducted a week's worth of observing the area and from that observation only one speeding ticket was issued. He confirmed that the OPP are aware and will continue to sporadically hit the area with the radar detection.

### **3. Grey County Common Ticket Book**

Chair Frew asked if there has been any new or updated information to relay about the common ticket book and where that stands. Staff Sergeant Ward could not provide an update at this time, or any further information.

## **9. Members Privilege - Good News & Celebrations**

Member Lewis explained that the Holstein Agro Expo held on August 14-16 in Holstein was a success. The event was held within the Provincial parameters of the COVID-19 pandemic and all rules were followed.
