Crime Unit

Grey Bruce CSCU Police Services Board Report – April & May 2021 **Supervisor: Detective Sergeant Byron SCHWASS**

The Grey Bruce County Crime Unit (6 Detectives) led, assisted or managed over 47 Benchmark Occurrences from April 1st to May 31st 2021.

These include 16 Sudden Death investigations (two of which are suspected opiate overdoses), 8 sexual assaults, a Human Trafficking incident, two online Child Exploitation incidents and assisted uniform personnel on a single day violent crime spree resulting in three charges of Robbery with Violence, 11 counts of assault, or assault with a weapon, and numerous Theft Over and Driving Charges.

Grey Bruce CSCU Police Services Board Report – June 2021 **Supervisor: Detective Sergeant Byron SCHWASS**

The Grey Bruce County Crime Unit (6 Detectives) led, assisted, or managed 40 Benchmark Occurrences from June 1st to June 30th, 2021.

This includes 12 Sudden Death investigations, five sexual assaults, two online Child Exploitation investigations, two Criminal Harassment investigations, as well as assisting other Major Crime Units with investigations/statements, and providing guidance to uniform personnel on criminal investigations.

The Grey Bruce Major Crime Unit continues to follow up leads, prepare for court, and investigate several ongoing Homicides which fall under the direction of OPP Criminal Investigations Branch (CIB). SPRUNG Homicide (Meaford), SOLOMON Homicide (Saugeen First Nation), JACKSON attempt murder (North Bruce Peninsula), and the CHISAR homicide. *D/Sgt and 2 DCs currently partnered with Hamilton Police Service on this. (Found Human Remains, Southgate). One D/C is also preparing for the murder trial of Nolan PANCHYSHYN.

Community Street Crime Unit

Grey Bruce CSCU Police Services Board Report – April 2021 Detective Constable Matt STARZECKI

The Grey Bruce CSCU continues to focus on drug trafficking and property offences as its focus. They continue to employ various investigative strategies and liaise with outside agencies and units in an effort to curb the drug flow into Grey and Bruce and as a result, curb the property offences directly associated with the drug use and distribution. The CSCU has executed drug warrants across the region while investigating cocaine, methamphetamine and fentanyl trafficking. Some warrant executions require the support of other units including the Emergency Response Team and the Tactics and Rescue Unit. In light of the opioid epidemic and some recent significant events of opioid poisoning in the community ongoing investigations focus on preventing these drugs from reaching vulnerable users.

Additionally, specialized training and equipment allowed the CSCU to immediately support local criminal investigations including an Attempt Murder in Tobermory. The specialized training available at a local level proves invaluable when drawing assets from other parts of the province would delay investigative progress and potentially the apprehension of suspects.

Acting Detective Sergeant Jeff DUDLEY has joined the CSCU as a team leader on a temporary assignment. A/DS DUDLEY brings a wealth of knowledge to the team having years of experience in Drug Enforcement and Intelligence. His presence is appreciated as he brings new ideas and strategies for co-ordinating drug and property crime enforcement.

Grey Bruce CSCU Police Services Board Report – May & June 2021 Acting Detective Sergeant DUDLEY

Over the last 2 months Grey Bruce CSCU has been busy with numerous drug trafficking and property offence investigations. In particular in June CSCU executed a search warrant for an indoor and outdoor cannabis marihuana grow. This required a great deal of resources including TRU, ERT, K9, Aviation, several CSCU teams, the Provincial cannabis enforcement team, hydro, the Municipality, Municipal By-law, fire,

and building inspectors. The total value of the property seized is approximately \$12,150,830.

In June members of the Grey Bruce and Huron Perth Street Crime Unit assisted Grey Bruce County Crime Unit executing a warrant for an address located in Northern Bruce Peninsula. Police searched the residence and located; 20 x edged weapons, a compound bow with 9 arrows, 2 x pellet pistols, 5 Molotov cocktails, 1 x .308 rifle, 1x black pellet rifle, 2 x rifle magazines, 577 x .22 cal live rounds of ammunition, 13 x 30/30 live rounds of ammunition and 5 x rounds of shot gun ammunition.

In June CSCU assisted uniformed officers with a motor vehicle collision that resulted in the seizure of weapons and drugs. 227 grams of cocaine, 70 grams of psilocybin (magic mushrooms), 18.1 grams of fentanyl, 16.9 grams of methamphetamine, 18 unknown pills, 181 Xanax pills, 29 lorazepam, 43 Clorazepam, packaging material, a cell phone, 4 airsoft pistols, 1 air soft rifle and a loaded handgun. Total street value of the drugs are an estimated \$23,289 and the estimated street value of the property is \$4500. This was an excellent team effort with CSCU and frontline officers.

During this time CSCU also assisted with the takedown of other CSCU investigations in the Province. This includes multi-jurisdictional investigations, locally lead initiatives and targeted enforcement. During the remainder of the quarter Grey Bruce CSCU continues to work on detachment initiatives and priorities with-in Grey Bruce County.

Training

News Release

Beginning on May 25, 2021, the OPP will equip uniform members of the Haldimand Detachment, members of the OPP West Region Emergency Response Team (ERT) and members of the West Region Traffic Incident Management Enforcement (TIME) team with body-worn cameras. This study will help inform broader OPP implementation of new technologies in the future.

OPP officers participating in the evaluative study will have the body-worn camera in plain view, and the camera has lights and indicators showing it has been activated. Officers are trained to give notice as soon as reasonably possible that a body-worn camera is in operation.

OPP officers participating in the study will turn on the body-worn camera prior to arriving at a call for service; at the earliest opportunity, prior to any contact with a member of the public, and where that contact is for an investigative or enforcement purpose. The body-worn camera will be turned off when the call for service or investigation is complete.

The OPP has conducted a comprehensive review of policies and procedures developed by our partner police agencies as it relates to the use and privacy impacts of BWCs. Procedures have been created to address potential privacy concerns and to ensure the security of the video once it has been recorded during the course of this study.

The OPP supports the implementation and use of tools or technologies that enable collecting better evidence, demonstrate greater accountability and transparency, and enhance public and officer safety in the communities we serve.

As you know, on January 1, 2019, new legislative amendments to the *Police Services Act, 1990*, came into force which mandate municipalities to prepare and adopt a community safety and well-being (CSWB) plan, in collaboration with their multi-sectoral partners, including police services and boards. As part of the planning process, municipalities and their local partners must utilize data from multiple sources and conduct consultations with their community to identify and address local priority risks to safety and well-being.

As a reminder, the deadline to prepare and adopt a CSWB plan is July 1, 2021. This new deadline provides a six month extension from the original deadline to help ensure that municipalities and their community partners can continue to dedicate the necessary capacity and resources to respond to the COVID-19 pandemic, while also providing adequate time to meet the legislative requirements to develop meaningful and effective CSWB plans.

The Ministry of the Solicitor General (ministry) has received feedback from local communities that there is a need to better understand the various provincial strategies/frameworks across ministries that align with CSWB planning. In response to this feedback, the ministry has developed a resource document which outlines broad, overarching provincial strategies/frameworks that align with CSWB planning and can support local CSWB efforts.

This resource document was developed in collaboration with the ministry's Inter-Ministerial Community Safety and Well-Being Working Group, which consists of representatives from nine Ontario ministries and the Federal government. Specifically, the document highlights collaborative, preventative and/or holistic approaches that aim to address local risks that lead to crime, victimization, addiction, drug overdose and/or suicide; that create protective factors in the community; and/or support vulnerable populations.

We know that communities are already doing a lot of great work to enhance the safety and well-being of Ontarians, and this resource document is meant to further support our local partners as they continue to develop and implement local CSWB plans.

I encourage you to share this resource document with your staff as well as with your municipal and community partners. As we move forward with CSWB planning in Ontario, the ministry is continuing to explore ways to support communities as they undertake the planning process and implement programs and strategies identified in their local plans.

Specifically, they represent collaborative, preventative and/or holistic approaches that aim to address local risks that lead to crime, victimization, addiction, drug overdose and/or suicide; that create protective factors in the community; and/or support vulnerable populations.

Ontario's Anti-Human Trafficking Strategy – An investment of \$307 million over five years (2020 – 2025) on a comprehensive action plan to combat human trafficking and child sexual exploitation. The strategy takes a proactive approach with initiatives across government focused on four key areas – raising awareness of the issue, protecting victims and intervening early, supporting survivors, and holding offenders accountable.

Equity and Inclusive Education Strategy / Education Equity Action Plan – The Strategy helps the education community identify and address discriminatory biases and systemic barriers in order to support the achievement and well-being of all students. The Education Equity Action Plan is a three-year strategy that involves working collaboratively with the community, to identify and eliminate discriminatory practices, systemic barriers and bias from schools and classrooms. As a result, every school board has an equity and inclusive education policy and a religious accommodation guideline in place to support student achievement and well-being.

School Mental Health Ontario (SMH-ON) supports District School Boards' Three-Year Mental Health Strategy and Action Plan – SMH-ON provides implementation support to all district school boards through clinical expertise, evidence-based resources/practical tools for educators, and the delivery of consistent professional learning to school-based mental health clinicians. SMH-ON works together with all 72 district school board's Mental Health Leadership teams to develop a three-year mental health and addictions strategy and one-year action plans that identify mental health priorities for the school year.

Ontario First Nation, Métis and Inuit Education Policy Framework – The Framework represents a collaborative approach which aims to increase the capacity of the education system to respond to the learning and cultural needs of First Nation, Métis, and Inuit students; provide quality programs, services, and resources to help create learning opportunities/support improved academic achievement and identity building; provide a curriculum that facilitates contemporary and traditional learnings among all students; and develop and implement strategies that facilitate increased participation. Through the Framework, all 72 district school boards have an Indigenous Education Lead and Board Action Plans for Indigenous education, which are specific to local needs and circumstances.

It encompasses five pillars – strengthening family well-being through higher quality, culturally appropriate and responsive community-based services, with a focus on prevention and early intervention; improving the quality of residential care provided to children/youth; promoting the development of stable and lifelong connections and supports for youth, with a focus on education/employment opportunities; improving the adoption experience and focusing on family-based options; and creating a more efficient, effective and financially

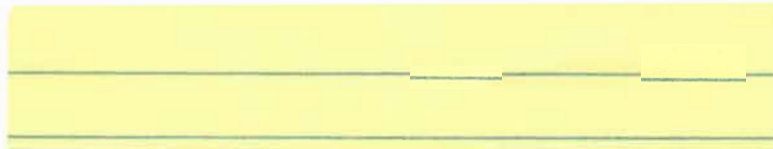
