# 10. Staff Updates

#### 10.1 Staff Presentation for Discussion

CAO Dave Milliner discussed the options for the Affordable-Attainable Housing Committee, discussing the current housing sectors available and the current projects underway in the Township of Southgate, including rental options, starter homes, senior options and property ownership options. Planner Clinton Stredwick discussed the new Official Plan Review that is being done by Planning Consultant, Ron Davidson. Planner Clinton Stredwick discussed the option to adopt inclusionary zoning practices into the new Official Plan, as well as the new Official Plan supporting a decrease in the minimum square footage to be able to build smaller, more affordable homes. CAO Dave Milliner discussed local housing projects that are currently under construction in the Township of Southgate.

#### 11. New Business

Members discussed the housing options that they think need to be a priority, including affordable rental homes, trailer parks and tiny homes. Chair Shipston asked the Planner about the height of apartment buildings and if there were restrictions on the how many floors could be done. Planner Clinton Stredwick mentioned that while there are no restrictions, the height of a building will impact critical services provided to the Township of Southgate, including fire services and police services. Planner Stredwick also mentioned that it is important to keep in mind the current layout of the Township, and that building higher apartment buildings may stick out in the Township. Members discussed who they may want to attend future meetings to speak from other organizations and will plan to invite Anne Marie Shaw, County of Grey Housing Manager, to the next Affordable-Attainable Housing Committee meeting.
