## Crime Unit



**Supervisor: Detective Sergeant Byron SCHWASS**

The Grey Bruce County Crime Unit (7 Detectives) led, assisted or managed 27 Benchmark Occurrences August 1st, to August 31st, 2022.

This includes 17 Sudden Death investigations as well as a 1 Criminal Harassments, 1 fraud investigation, and 6 reported sexual assaults.

This Unit is also assisting other Major Crime Units with investigations/statements, and providing guidance to uniform personnel on criminal investigations. Two DCs were actively engaged in court on the SPRUNG homicide, with pre trial motions in mid August.

The Grey Bruce Major Crime Unit continues to follow up leads, prepare for court, and investigate several ongoing Homicides which fall under the direction of OPP Criminal Investigations Branch (CIB). SPRUNG Homicide (Meaford) completed the preliminary inquiry for 1<sup>st</sup> degree Murder and is now proceeding to trial. SOLOMON Homicide (Saugeen First Nation) trial pending. The JACKSON attempt murder (North Bruce Peninsula), and the CHISAR homicide (male arrested for 2<sup>nd</sup> degree Murder) both are still under investigation.

All National and Ontario Sex Offenders, Hate Crime / Extremism Investigations and High Risk to re-offend Offenders and High Risk Domestic Violence Offenders continue to be managed by the Grey Bruce County Crime Unit.



## **Community Street Crime Unit**

Grey-Bruce Community Street Crime Unit (CSCU) were involved in several major investigations in July & August 2022.

In July 2022 a search warrant was executed in South Bruce Peninsula in which over \$150,000 of stolen property was recovered including firearms, ammunition, and motor vehicles. One party was charged. The execution of this search warrant solved over five (5) historic thefts dating back to 2019 and as far away as Barrie.

In August 2022 a search warrant was executed in Meaford in which firearms and ammunition were recovered and two parties were charged. Grey-Bruce CSCU continues to collaborate with South Bruce CSCU on joint investigations and search warrant executions as was the case when a search warrant was executed in Kincardine less than 24hrs after a Break and Enter to a commercial business. The stolen property was recovered, and one party charged.

CSCU located and apprehended a series of wanted persons in our detachment area and they were arrested on outstanding warrants as well as additional criminal charges.

Traffic Safety has been a core priority of the Grey-Bruce OPP in response to a vast increase in fatal motor vehicle collisions in the summer of 2022. Our newly implemented Traffic Management Unit (TMU) has assisted greatly with efforts to improve highway safety through proactive patrols, public education, enforcement and collision investigation. The unit consisting of two (2) constables and one (1) sergeant have been immensely effective in enforcing our local and provincial traffic objectives. The “Big 4” remain the leading cause of traffic related collisions and fatalities and with our concerted efforts and increased visibility we hope to make our roads safer for our communities.

## MOBILE CRISIS RESPONSE TEAM FINALIZED

The Grey Bruce and South Bruce Ontario Provincial Police (OPP), in partnership with the Grey Bruce Health Services (GBHS) are proud to announce that a Mobile Crisis Response Team (MCRT) has been finalized for the area.

GBHS and the Grey Bruce and South Bruce OPP, have entered into a community based, collaborative partnership to provide a Mobile Crisis Response Team to individuals and families within the Grey Bruce and South Bruce OPP detachment area, who are experiencing mental health and/or addiction related crisis.

The partnership aims to achieve the following goals and objectives for persons in Grey Bruce and South Bruce who contact police when experiencing mental health and/or addiction crisis:

- Individuals experiencing crisis will have access to timely crisis assessments by a skilled mental health professional.
- Individuals will have access to available and most appropriate level of service, in their home/community environment thereby potentially diverting unnecessary presentations to the local Emergency Departments.
- Individuals experiencing crisis/difficulties will be stabilized within their communities whenever possible, and with coordinated care, will have fewer episodes requiring crisis intervention and/or contact with police services.
- Individuals experiencing crisis will have transitional supports provided and improved coordinated care through timely follow up contacts, support in the transfer of care with the hospital when required, and referrals to case management support.
- Following crisis assessment and intervention, individuals will have improved access to ongoing supports and services through identified care pathways, and transitional support.
- Individuals experiencing crisis may, whenever possible, be appropriately deferred from the criminal justice system.
- Potential for reduced hospital visits to both local and Schedule 1 hospitals for persons experiencing a mental health and/or addiction presentations
- Implementation of an evaluation process and quality improvement to achieve a high quality of service.
- Participation in research, education, and training opportunities to support the activities of the MCRT.

Involved partners will continue working over the next few months towards the launch of the program, which is planned before the end of the year.

In the follow-up to the Member AGM in May 2022 the Member bylaws were updated to include two (2) revisions.

#### **4.03 Election and Number of Directors**

The number of directors shall be fifteen (15), unless changed by special resolution or otherwise in accordance with the Act.

Directors shall be elected at a meeting of members on a show of hands unless a poll is demanded, in which case such election shall be by ballot. Retiring directors shall continue in office until their successors have been duly elected or appointed.

May 27, 2022 - OAPSB Membership, hereby authorizes By-law Number 1-Section 4.03 be amended to increase the number of directors from fifteen (15) to seventeen (17) directors. One candidate from the North-Zones 1/1A (commencing 2022) and one indigenous candidate at large originating from a First Nations Board (commencing 2023)

#### **4.04 Nomination of Directors**

Not less than forty-five (45) days prior to the annual meeting of members, each of the following shall notify the Board of its nominee or nominees for election to the board at such annual meeting:

- (i) Each Zone shall submit one nominee;
- (ii) The Big 12 (excluding Toronto) shall submit four (4) nominees; and
- (iii) The Toronto Police Services Board each shall submit one nominee.

At each such annual meeting, the representatives of the Police Services Boards operating pursuant to Section 10 of the PSA shall select and advise of three (3) nominees, one (1) selected by such Boards in Zones 1 and 1A, one(1) selected by such Boards in Zones 2 and 3 and one(1) selected by such Boards in Zones 4, 5 and 6.

May 27, 2022 - that the OAPSB Membership hereby authorizes By-Law Number 1-Section 4.05 be amended to increase the term of office from a one (1) year to a three (3) year term, at the beginning of the 2023 terms of Directors.

THAT the bylaws be updated to include

clarification regarding 3-year terms

- The First Nations position will be elected in 2023 for a 3-year term
- Big 12 starting 2023 for 3-year terms
- Zone Directors 1A - 6 starting 2024 for 3-year terms
- OPP (4 positions) starting 2025 for 3-year terms
